

NOTICE TO BIDDERS

PUBLIC NOTICE IS HEREBY GIVEN that sealed bids will be received by the **Town of Secaucus**, County of **Hudson**, State of New Jersey for the **2018 CDBG 1ST STREET ROADWAY RECONSTRUCTION**.

Specifications and other bid information may be obtained at the *Town of Secaucus Engineering Department, 1203 Paterson Plank Road, 4th Floor, Secaucus, Hudson County, New Jersey* during regular business hours *9:00 A.M -4:00 P.M.*

Said Bids will be received, opened and read aloud in public at **The Town of Secaucus, 1203 Paterson Plank Road, 2nd Floor Town Hall, Council Chambers** on **June 27, 2019 at 10:00 AM** prevailing time.

A NON-REFUNDABLE fee of *\$50.00 (Fifty Dollars)* in the form of a check payable to the *Town of Secaucus* will be required for each set of specifications.

PAYMENT MUST BE RECEIVED PRIOR TO OBTAINING SAID SPECIFICATIONS, EITHER BY MAIL OR IN PERSON. NO BIDS ARE TO BE DROPPED OFF AT THE ENGINEER'S OFFICE.

The project Base Bid includes HMA Milling & Overlay, reconstruction of concrete curb, sidewalk & driveways, installation of ADA curb ramps, removal and replacement of inlet frames and grates, removal of trees and planting of new trees, and restoration.

The project Alternate Bid A includes additional HMA Milling & Overlay and all associated work. Alternate Bid A pay items may be included in the work at the discretion of the Owner. Should Alternate Bid A be awarded, the award will be made for the entire Base Bid + Alternate Bid A pay items.

The Town of Secaucus reserves the right to consider bids for sixty (60) days after the receipt thereof, and further reserves the right to reject any or all bids, either in whole or in part and also to waive any informality in any and make such awards or take action as may be in the best interest of the Town of Secaucus.

Bids must be on both the Base Bid Form and Alternate Bid A Form prepared by The Town of Secaucus Engineering Department, in the manner designated therein and required by the specifications, must be enclosed in sealed envelopes bearing the name and address of the bidder on the outside and also bearing on the outside reference to the particular work bid upon. Two additional copies of the Proposal Section shall be included with the Bid Package submitted in sealed envelopes. Said bids shall be addressed to the Town Clerk, Town of Secaucus, 1203 Paterson Plank Road, Secaucus, NJ 07094.

Each bid shall be accompanied by a certified check, cashier's check or bid bond duly executed by the bidder as principal and having as surety thereon a surety company approved by the Town of Secaucus in an amount not less than ten percent (10%) but in no case in excess of \$20,000.00 of the amount bid. Any such bid bond shall be without endorsement or conditions. Bid shall be accompanied by a certificate letter from a surety company stating that it will provide the bidder with the completion bid.

The award of the contract shall be made subject to the necessary moneys to do the work being provided by the Town of Secaucus in a lawful manner. The contract to be executed by the successful bidder will provide that it shall not become effective until the necessary moneys to do the work have been provided by the Town of Secaucus in a lawful manner. The award shall further be subjected to the securing of necessary State, Federal, or Local permits governing the work.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27-1.1 et seq. (Affirmative Action), N.J.S.A. 34:11-56.25 et seq. (New Jersey Prevailing Wage Act), and Americans with Disabilities Act of 1990 (42 U.S.C. 12101, et seq.).

The contractor is further notified that he must comply with N.J.S.A. 52:25-24.2, and submit a Disclosure of Ownership Statement.

The contractor is further notified that he must comply with the N.J.S.A. 34:11-56.48 et seq. Public Works Contractor Registration Act and he and any subcontractors must be registered in accordance with the act.

The contractor is also further notified that he must comply with N.J.S.A. 52:32-44 and submit proof of business registration and submit proof of business registration for any named subcontractors in accordance with the act.
